Candidate Entrance:

• Directions to Clinic entrance; north bound on Greene Street; turn right on E. Ermina Ave. Turn right into P10 parking lot (by SCC greenhouse). Building 9 entrance is directly east of parking lot.

3. Preparing for the Exams

a. <u>Restorative Exam</u>, if applicable

- Equipment, Instruments and Expendable Dental Materials: Refer to the respective WREB Candidate Guide for a list of materials and armamentarium that the Candidate must provide.
 - **A. Handpiece Hookups:** High speed handpieces are as follows: cavo brand with 6-hole coupler with water and no fiber optic. Slow speed hand pieces are as follows: cavo brand with 4-hole coupler. These will be available for students to use at no charge and will be set up at each unit.
 - **B.** Air/Water Syringe Tips: Air/water syringe tips will be disposable and thrown away at the completion of each exam. Water available in cups only; not through unit.
- **C.** Curing Lights: SCC will provide curing lights and orange shields to candidates.
- **D. Expendable Materials:** Expendable dental materials supplied by the school are noted in *Appendix C*.

4. During the Clinical Exam

- Dental Operatory Units: adec unit/model 200
- Infection Control (Surface Asepsis): candidate will be expected to remove all barriers on chair, dental unit and countertops and dispose of in the garbage provided. The candidate must spray the entire dental unit and chair with co-foam or use caviwipes and wipe counter tops, all handpieces and hoses, air/water unit and hoses, suctions and hoses, the entire chair, and the overhead light. The candidate then must re-barrier the unit with freshly washed clean hands in preparation for the next candidate.

A. Hazardous Waste Disposal (exam-type specific):

- Restorative: amalgam scraps must be placed into the 5-gallon bucket located in our sterilization area labeled "hazardous waste – amalgam". Please only place scrap amalgam into the provided bin, not the amalgam capsules or bags that were used to catch amalgam, which should be placed in the garbage can provided.
- Emergency Medical Equipment: emergency equipment (i.e. oxygen, AED, first aid kits, ice packs, etc.) are located on the west end of the clinic on the pony wall and just inside the storage room door on the west end of the clinic. If you or another candidate need emergency treatment let us know right away so we can get the AED, oxygen, first aid kit as needed and call 911. To dial out on the clinic phone, dial 9 and then 911.



WREB Check-In Procedures

- Arrive onsite and be prepared thirty (30) minutes prior to your scheduled test session to accommodate check-in procedures. Time extensions are not permitted; arrive early.
- Identification required for admittance. Refer to the WREB Dental Hygiene Objective Structured Clinical Examination (OSCE) Candidate Guide for exam security information and identification verification requirements. Available on the Exam Preparation page of the WREB website.
- Prior to entry, you will be required to raise your pants legs above your ankles, empty and turn all pockets inside-out, and raise shirt sleeves above your wrists. Eyewear, hair accessories and ties are subject to inspection. Violation of security protocol may result in the confiscation of prohibited devices and termination of your exam.
- **Prohibited personal items** include cellular phones, cameras, hand-held computers, PDAs or other electronic devices, pagers, watches, wallets, purses, hats, bags, coats, books, and notes. Items may be placed away from testing area. Candidate assumes sole responsibility for safety of any prohibited personal items.
- Acceptable personal items include identification, personal eyewear.
- You will be provided with your **Candidate ID Badge** prior to entrance, assigned an iPad and be directed to your test area.

WREB Exam Protocols

- A WREB representative will assign you to a workstation and log you on to the computer which starts the exam.
- **Countdown Clock.** On screen clock displays time remaining for each section.
 - Introduction. You have up to two (2) minutes to review the introduction.
 - **Terms and Conditions.** You have up to three (3) minutes to review and accept the non-disclosure terms and conditions. Refusal to accept the terms and conditions within the allotted time will result in **forfeiture of your exam attempt and fees**.
- Timed Exam. You will have up to 2-hours to complete the exam.
- **Exam Items.** Multiple choice items are discipline based. Some items utilize images. All items have only one correct response.
- **Exam Security.** The testing area is monitored continuously by WREB representatives. Notify them immediately for assistance with any computer-related issues. Questions related to exam content are prohibited.

Reminders

- **Breaks are** <u>not</u> permitted, under any circumstances, during the examination. If you leave the testing room prior to completion, your examination will end immediately.
- The exam site host (school) provides **expendable materials** for Candidate use during the examination i.e. masks, hand sanitizer, necessary barriers, etc. The school is responsible for any deviation from this list. Materials provided are the brands used by the school. If you require a specific brand, you must bring it with you.

Like many of you, we are concerned about the potential health implications of the COVID-19 virus (also known as Coronavirus). As a result, we will be implementing a screening process to ensure candidate safety.

Requirements for candidate safety:
