# **Dental Hygiene Clinical Examinations**

The Dental Hygiene Clinical Examination will be available in either a patient-based form or manikin-based form, if applicable.

# Dental Hygiene Patient-Based Clinical Examination

#### Check-In Deadline

Candidates are so well prepared when they come into the clinic now that they rarely take the 45-minutes allowed to submit their patient to Check-In. Therefore, we eliminated the 45-minute deadline and eliminated the Check-In time penalty.

#### **Periodontal Assessment**

For the exam year 2021, WREB removed the Classification of Disease question. The current AAP Guidelines for accurate classification of the periodontal condition by Staging and Grading require more detail and patient information than the current clinical examination format can test (i.e. systemic conditions, historic tooth loss etc.). Additionally, students are now tested on this subject on the National Boards, adding support to the decision to retire this question.

**Periodontal Assessment Questions Scoring.** A maximum of eight (8.00) points are possible. The remaining three questions will be scored a maximum (2.667) points each. Partial credit of (1.33) point may be given for Question #1 (radiographic bone loss).

### **Patient Treatment Form**

Historically, there were two forms; *Local Anesthesia Dosage* & *Continuing Care Form* that we have now combined into one. The *Patient Treatment* form is completed and signed prior to Chief Examiner approval.

- Record the dental hygiene treatment plan for the examination
- Record any medications taken by Patient
- Record contact information for Practitioner or dental hygiene school
- Patient signature

**Extraoral and Intraoral Examination.** Candidates may complete the Extraoral and Intraoral examination on their Patient and record their findings on the front of the *Candidate Assignment Form* either:

- Before they submit their Patient at Check-In, or
- During their assigned clinic treatment time

# **Dental Hygiene Manikin Clinical Examination**

The Manikin examination is comprised of two exercises: 1) Assessment and Detection, and 2) Removable Calculus. Each exercise of the examination is completed on a separate WREB quadrant. The typodont is positioned on a rod post to simulate the natural position and clinical treatment of a patient.

- The Assessment and Detection exercise requires the candidate to assess periodontal conditions, accurately record periodontal measurements, and note the presence of subgingival calculus on a maxillary quadrant.
- The Removable Calculus exercise requires candidates to thoroughly remove subgingival calculus from all teeth in the assigned quadrant using ultrasonic and/or hand instrumentation.

The Assessment and Detection and Removable Calculus quadrants are unique in design. The color, type, and size of the subgingival removable calculus has been designed to provide the Candidate with a more realistic clinical experience. The WREB calculus is unique and different than the calculus currently being utilized in educational programs and by other testing agencies.

For those schools that are currently using models in their dental hygiene curriculum, the WREB quadrants are compatible with ModuPro DH with articulator and the ModuPro One with articulator. A Candidate also has the option to only purchase the Acadental articulator and two carrier trays. Refer to the Acadental website for more information.

WREB recommends that you check with your state licensing board to confirm acceptance of the Manikin examination.

# Local Anesthesia Written Examination

WREB is aware of the discrepancies between referenced textbooks in the Local Anesthesia Candidate Guide regarding MRD and prilocaine.

However, the test items that are on the written examination are still reflective of the tables referenced in the WREB Local Anesthesia Candidate Guide. When preparing students for the written examination regarding MRD (drug information) please continue to use these tables.

# Local Anesthesia Clinical Examination

### **Critical Aspects of the Injection**

• Candidates may change their submission, without penalty, at any time prior to an Examiner checking the Patient's landmark teeth and penetration sites.

### **Category \*1** was separated into the following categories:

- Medical History
- Anesthetic and Syringe Selection
- Oral Conditions

### **Anesthetic and Syringe Selection**

• The error criteria, "Absolute contraindication to anesthetic or vasoconstrictor "was added to both the IA and PSA injections. This is also a Stop and Hold.

#### **Oral Conditions**

- The error criteria, "Intraoral sore at injection site" was added. Each site will be evaluated separately.
- If an intra oral sore is present, the Candidate has the option of using the opposite side for the injection without penalty.

### **Category 2 Syringe Preparation and Handling**

• The error criteria, "Needle not securely attached to syringe" was added.

#### Clinic Entrance and Exam Procedures

WREB is discontinuing the practice of allowing Candidates to have additional syringes **loaded** on a separate tray. In many cases, this was an unnecessary waste of needles and anesthetic. They may have additional syringes, just not loaded.

Candidates may have additional cartridges and syringe(s) available to load. Additional
cartridges and needles should be set aside on a non-contaminated surface.

# Restorative Clinical Examination

No changes to any Restorative examination criteria.

Candidate restorations may not be graded immediately after each clinical session. A cumulative grading session will be scheduled, either during the last scheduled clinical session of each exam or just prior to the last scheduled clinical session of each exam. WREB is still providing preliminary results, once graded, as well as providing onsite retakes for those eligible.

If the exam lasts longer than (1) clinical day and students are unable to collect their evaluated typodonts, WREB will arrange the return of each attending schools typodonts in bulk, to the program Director, via FedEx or UPS at the conclusion of the exam.

# WREB Examination Forms

Copies of all 2021 forms that students/instructors need to become familiar with, will be available to download via the WREB website in January. Original exam forms will be included in the exam packet each student receives onsite during the Q & A session, held prior to each exam.
